High cost and unwarranted variation in pricing make our current health care system unsustainable. The Alliance is focused on two areas of activity to reduce price variation in Washington:

- Establishing the capability to measure and report variation on the price of care.
- Targeting actions to address selected areas of high price and unwarranted variation in pricing.

**UNDERUSE OF** 

When patients receive the evidence-based care at the right time for the right reason, it increases the likelihood that disease will be identified early and managed and reduces the potential for avoidable complications and financial burden. The Alliance is focused on three areas of activity to reduce underuse of effective care in Washington:

- Improving patient experience.
- Improving management of chronic disease for adults in the primary care setting and address disparities in care as they are identified.
- Improving the rate of prevention screening for cervical, colorectal and breast cancer.

REDUCING OVERUSE



More care isn't always better care. Unnecessary tests and procedures contribute to waste in the system and increase the risk to patients. The Alliance is focused on five areas of activity to reduce overuse of care in Washington:

- Reducing the avoidable use of emergency room (ER) services; reducing 30-day hospital readmissions; reducing the rate of elective, preference-sensitive procedures; and reducing the rate of non-evidence based testing and services.
- Reducing unwarranted variation in resource use and intensity of care.
