Purchasers Unify to Support Primary Care Transformation in Washington State

A recent <u>study</u> shows patients who receive primary care receive significantly more high-value care and slightly more low-value care, but reported significantly better health care access and experience than those who did not. Using data from the Medical Expenditure Panel Survey over a 12-year period, the study found those with primary care more frequently had cancer screenings, flu vaccines, and high blood pressure checks, while those without missed substantial health benefits, such as cancer screenings, diagnostic and preventive testing, diabetes care, and counseling.

The Washington Health Alliance brings together those who give, get and pay for health care to create a highquality, affordable system for the people of Washington state. It is the value of primary care and the critical role it plays in keeping people healthy that motivated the Alliance and the Purchaser Business Group on Health, formerly Pacific Business Group on Health (PBGH), to express support for the state's current efforts to transform the delivery of primary care. In a letter to the Washington State Health Care Authority (HCA) last week, the purchasers encouraged providers and health plans to "work together with those of us paying for health care services to generate new payment models that increase the proportion of health care spending on primary care." Signers to the letter collectively represent more than 350,000 individuals in Washington state, including the Association of Washington Cities, King County, Puget Sound Energy, SEIU 775 Benefits Group, and the Washington Health Benefit Exchange.

The purchaser letter followed the signing of a Memorandum of Understanding (MOU) last fall between insurance plans, the HCA, Governor Jay Inslee's office, and the Washington State Medical Association to support the HCA's Multi-Payer Primary Care Transformation Model. Amerigroup Washington, Community Health Plan of Washington, Coordinated Care, Kaiser Foundation Health Plan of Washington, Molina Healthcare, Premera Blue Cross, Regence BlueShield, and UnitedHealthcare have all agreed to the MOU.

The Alliance, PBGH, and the purchasers who signed on to the letter discussed their priorities and areas of collaboration in a meeting last week with the HCA and health plan leaders, including:

- data integration and aggregation;
- primary care capacity;
- attribution of primary care providers to patients;
- telehealth;
- behavioral health; and
- care coordination for complex patients.

How Can Hospitals Advance Equity?


