This is an auspicious time for the Alliance. Thanks to a 2012 grant from the State, last month we were able to include county-level results for all of Washington in the Community Checkup for the first time. Reflecting our expanded reach, we changed our name to the Washington Health Alliance and launched a brand new website with statewide data and increased functionality for visitors and members.

Now we are embarking on the next stage of our statewide expansion. Over the coming weeks, we will begin visiting six communities around the state to introduce the Alliance in meetings with local leaders from hospitals, medical groups, regional health improvement collaboratives, public health and business. Our goal for the meetings is to help people better understand the Alliance and our reporting, including our plans for statewide expansion, and to collect feedback on their interests and concerns. Board of Directors Update

The Board approved the 2014 Alliance budget and a five-year plan incorporating strategies that will advance the Alliance's goals to reduce the price of health care; reduce overuse of health care; and reduce underuse of effective health care. The Board also previewed the Alliance's role and preliminary steps for creating a statewide All Payer Claims database, which is made possible due to a federal grant received by the State of Washington. The Board voted to approve the initial scope of work conceived by a grant steering committee and to sign the State's proposed contract.

The Alliance's Medical Home Pilot project ended in December and the project director gave a recap on outcomes and lessons learned. The pilot project collected data from 7 health plans and 8 medical groups. The focus was on how payment reform might affect hospital utilization, including reducing avoidable ER and inpatient visits with better care coordination. Results of the Medical Home Pilot project will be released this summer.

The Alliance unveiled a new logo and gave the Board a preview of the 2013 Community Checkup Report. A common theme in the report is that there is much variation between delivery systems and that each delivery system contains both strengths as well as areas for improvement.
