## LETTER FROM THE EXECUTIVE DIRECTOR

Dear Participant,

Late last month, the Alliance released the results of its second patient experience survey, which measures patients' experiences with local primary care providers. This initiative, which the Washington Health Alliance has named *Your Voice Matters,* is an important element in understanding the quality of care in our region. The Alliance is the only organization in Washington State to have systematically asked patients about their primary care experience <u>and</u> made comparable results publicly available.

Patient experience refers to what happens to people when they are interacting with the health care system and seeking to have their needs met. Patient experience surveys ask patients *whether or not or how often* certain events happened and not simply the patients' expectations and feelings, which can be highly subjective. Research shows that, in addition to being a factor that is highly valued by patients and their families, patient experience is also correlated with improved clinical outcomes. Read more

# **Board of Directors Update**

The Alliance Board of Directors met on February 25. The Board marked the retirement of founding board member Diane Zahn, and thanked her for her years of service on the Board.

The Board was given an update on the Alliance's efforts on the grant deliverables due to the Office of Financial Management (OFM) for the Data Center grant and on the Alliance's meetings across the State with regional collaboratives. The Alliance met with regional collaborative networks and stakeholders in Spokane, Mount Vernon, Bellingham, Tri-Cities, Yakima, and Wenatchee in January and February. Responses to a readiness survey given to all participants at the meetings were generally encouraging of greater transparency.

The Board also discussed guidelines for Accountable Care Organizations (ACOs) that members of the Purchaser Affinity Group developed to evaluate ACO proposals from delivery systems and/or health plans.

Alliance staff reviewed the patient experience survey and gave an overview of the results (see Executive Director letter above). Back to top
