LETTER FROM THE EXECUTIVE DIRECTOR Dear Participant,

Welcome to the Washington Health Alliance! Our expansion as a statewide organization is now officially reflected in our new name and look. It will take us some time to expand our work, but we are excited by the opportunity to branch out and to help amplify the great work others across the state have already undertaken.

Going statewide is a natural progression for the Alliance. We have been able to establish our work as a valuable contributor to health care improvement, particularly in performance measurement and reporting. Proof of that can be found in a just-released national report from the Health Care Incentives Improvement Institute (HCI3), a nonprofit focused on improving health care quality and value. HCI3 awarded Washington one of only two states with "A" grades in its "State Report Card on Transparency of Physician Quality Reporting." The Alliance's Community Checkup report, along with its patient experience survey report, formed the basis for the state's outstanding score.

The 2013 Community Checkup results are now available. As the first step in our statewide expansion, we are reporting county-level results for all 39 counties in the state.

Community Checkup Webinar

January 12, 12:15 - 1:15 Alliance Deputy Director Susie Dade will review We recognize that many communities across Washington have undertaken major efforts to improve the quality of care patients receive. We also realize that public reporting will be a new and challenging concept for many, as it was in the Puget Sound region when the Community Checkup was first introduced. But what we learned from our experiences with the Community Checkup is that those concerns were allayed once the Alliance demonstrated its intent to report valid and statistically reliable results and how useful its data is to understanding performance and opportunities for improvement. The Alliance's goals align with those of other stakeholders committed to improving our health care system.

The Alliance plans to engage directly with a few communities around the state, to learn more about the work being done and to discuss how the Alliance and its mission can support local efforts underway. We know that other communities have valuable lessons to share. Starting in 2014, we intend to identify two population centers where we can collaborate on introducing reporting on measures of effective care at the medical group and clinic level. Over time, the Alliance plans to roll out medical group and clinical level reporting statewide. Based on our experiences, we believe that this will provide a benchmark for discussion about performance and how to improve the quality of care for all Washingtonians.

In addition to our new name and logo, we have a brand new website at www.wahealthalliance.org, The new site offers increased functionality and a design for mobile platforms. You'll be able to see a calendar of events and a member sign up for All-Alliance meetings through the site. Alliance Closes Data Collection on New Patient Experience Survey

Earlier this month, the Alliance closed data collection on its most recent patient experience survey. Good News! Out of 197 clinics, the Alliance expects to have results on one or more of the four measures for 186 clinics – an increase of 30 clinic sites from 2012. These results will be publicly reported during 1st quarter 2014. Unfortunately, we did not get sufficient responses for 11 of the clinics to have publicly reportable results on any of the four measures. Alliance Purchaser Members to Sponsor eValue8 again in 2014

The eValue8 RFI questions are organized into eight modules which closely align with how plan

sponsors think about health plan activities. Health plans across the country have had a lot of input into development of the eValue8 tool, along with other highly reputable national organizations such as the Agency for Healthcare Research and Quality (AHRQ), the Centers for Disease Control and Prevention (CDC), Catalyst for Payment Reform (CPR), the National Committee on Quality Assurance (NCQA), and other federal, state and academic centers. The eight modules include:

1. Business Profile of the Health Plan 2. Physician

& Hospital Management & Measurement

3. Helping Members Stay Healthy

4. Helping Members Become Good Consumers

5. Helping Members Manage Acute/Episodic Conditions

6. Helping Members Manage Chronic Conditions (includes Behavioral Health)

7. Pharmaceutical Management

8. Client Support, Data Analyses and Reporting

Together with its purchaser members, the Alliance invited six commercial health plans to participate in the eValue8 process. We are pleased to announce that five of the six have agreed to participate. The five include: Aetna, Cigna, Group Health, Regence BlueShield and UnitedHealthcare. Premera Blue Cross was also invited but has declined to participate. Health plans have until mid-February to respond to the RFI and scored results will be available during the second quarter of 2014.
