

LETTER FROM THE EXECUTIVE DIRECTOR

In May, the Alliance released "Hospital Value in Washington State" – the first report in the state and one of the few nationally – that combines scores on hospital quality, patient experience and cost. Since its release, we have received many positive comments and some media attention centered on the report's findings that higher cost doesn't mean higher quality care. However, as I said when I spoke at the National Employer Summit earlier this year, a database is just a database unless you can actually use the information to inform and drive action. So now that we have the data, how do we use the information in the report to drive value-based purchasing and help those who get, give and pay for healthcare make better choices?

Members of the Alliance Purchaser Affinity Group reviewed the results in June and made recommendations for purchasers, which were shared with the Alliance Board of Directors.



Kentucky Creates Core Set of Primary Care Measures

Kentuckiana Health Collaborative (KHC) and the Kentucky Department for Medicaid Services have partnered to develop a core set of primary care measures aligning the priorities of Medicare, Medicaid, and commercial insurers in the state. More than 70 experts from across Kentucky participated in this effort, which contains 32 unique measures across prevention, pediatrics, chronic and acute care, behavioral health, and cost/utilization.

Washington State established a Statewide Common Measure Set for healthcare quality and cost in 2014 through a Governor-appointed committee co-led by the Alliance. We are pleased to learn that other states such as Kentucky are working to provide a foundation for health care accountability and performance measurement. A comparison of our Washington list of measures and Kentucky's measures shows tremendous overlap on a majority of measures. Mayo Clinic Helps Providers Address Depression Treatment Through Shared Decision-Making

A new resource from the Mayo Clinic offers a tool for health care and behavioral health providers to use with

their patients in the medication treatment of depression. Available in English and Spanish, the tool includes a printed decision aid and visual demonstrations on how to use the tool.

Shared decision-making is a process that allows patients and their providers to make healthcare decisions together, taking into account the best scientific evidence available, as well as the patient's values and preferences. Depression affects about 7 percent of people in the U.S. Washington State is taking action by transforming health care to deliver coordinated care for both physical and mental health. Medication is one of several approaches a provider and patient may choose to address depression. Included as part of the health plan, this tool can make the choice of medication an easier shared decision between patient and care provider.
