LETTER FROM THE EXECUTIVE DIRECTOR

In 2014 Washington became one of the first states to agree upon a common measure set for health care quality and cost. The impetus was to align measurement efforts across a wide variety of organizations, send a common message about performance accountability and create the basis for purchasing health care based on better value, i.e., high quality at an affordable price.

That version of the Common Measure Set was a “starter set,” intended to be a first iteration that evolved over time. Because the work of improving health and health care is ongoing, the Common Measure Set adapts to changing conditions to include other priority issues and sources of data. The most recent updates focus on pediatric-related measures that will help more Washington children have a healthy start to life. [Read more from our executive director.](#)

Hey health care providers, did you know?

Sometimes, the Washington Health Alliance just hears about a program that they want to promote because of the benefits that it offers to people in need. Here is a great example: Angel Flight West. A member of the Alliance's Purchaser Affinity Group is a pilot and volunteers his time with this program. As a health care provider, we thought you'd like to know about it.

Sometimes, your patient needs care that your facility can't offer. So you refer them to a specialist. The patient's insurance -- private or public -- will cover the treatment but they have no way to get there. And when the destination is hundreds of miles away, getting there can seem impossible.

That's where Angel Flight West comes in. With a network of volunteer pilots and commercial airline partners, AFW arranges more than 4,000 flights each year throughout the 13 Western states. In Washington state, using their network of about 160 Washington-based pilots, over 600 of these flights were arranged in 2016.

It's all free. There's no charge to the passenger, the physician or hospital, or the requester. AFW's generous pilots donate all costs.

New Community Checkup highlight shows HPV vaccinations in Washington

An estimated 80 million Americans have HPV, and the CDC reports that in the U.S., more than 1 in 5 adults aged 18-59 has high-risk HPV. The good news is that most HPV-caused cancers can be prevented with a vaccine. HPV vaccines are safe and highly effective in preventing infection from certain types of HPV when given before a person is exposed to the virus, starting at age 9. However, according to the 2016 Community Checkup, on average, just 17 percent of adolescent boys and 22 percent of
