Low Back Pain Implementation Collaborative

Sharon Eloranta and Denise Giambalvo presented an overview of the Low Back Pain Implementation Collaborative supported by Arnold Ventures. We are launching on February 3 with the overall aim of "advancing the market to improve the value of care for all patients with low back pain in Washington state." We have developed a multistakeholder collaborative and will be focusing on changes that address reductions in low-value care and improvements in high-value care. We will be addressing multiple mechanism and levers for change including patient education, benefit design, provider culture, workflow and payment. Measures will be developed at the kick-off meeting.

There will be individual meetings with each stakeholder on a monthly basis to follow-up with progress and challenges. Future schedule meetings will be held in April, August and November 2022. There will be an optional wrap-up meeting in 2023.

The initial goal was to bring in 20 organizations. At this time the total is 27: 13 Purchasers, 6 Providers, 4 Health Plans and 4 Affiliates.
