Ms. Giunto informed the Board that the Pricing Methodology Ad Hoc Workgroup completed their comments on the draft methodology and availability reports. The Pricing Subcommittee will review and take action on the recommendations at their June 19th meeting. Ms. Giunto informed the Board that the recommendations will be presented at the June 27th Board of Directors meeting for their approval. Ms. Giunto shared with the Board that she has received both positive and supportive feedback from the community regarding the pricing letter sent on May 16th informing about the Alliance commitment to provide pricing data.

Ms. Giunto provided an overview of a new report that is currently under development tentatively named; Medicare Value: A View of Quality and Gross Charges. The target release date is July 2017. After a brief discussion Ms. Giunto confirmed that there will be a review by the Board prior to release of the report.

Ms. Giunto informed the Board that the Executive Committee approved the 2016 Financial and Compliance Audit as presented by the auditors from Jacobson & Jarvis at the EC meeting on May 11th. The auditors will present the approved audit at the June 27th Board meeting.
