Executive Director Report and Recap of the Year

- Opioid Call to Action
- Supported the DOH/Qualis Health Practice Transformation Hub, value-based purchasing training for clinicians
- Facilitated "eValue8 Lite" meetings between health plans and purchasers
- Collaborated with the RAND Corporation's Centers of Excellence
- Partnered with Castlight to include Community Checkup results in Castlight's analytic platform
