#### Introductions, approval of meeting minutes

Members introduced themselves and we welcomed our guests.

#### **COVID-19 Roundtable**

The planned agenda was reorganized to include an open discussion on the challenges faced by the ongoing threat of COVID-19, including the challenges of increasing vaccination rates, the

threat of the Delta variant, and the many stresses this places on the health care system, particularly from a staffing perspective. The discussion continued for the first 75 minutes of the meeting. At the urging of the committee members, the Alliance captured the important messages shared during this segment of the meeting and <u>published it as an open letter to the community.</u>

#### **Update from the Primary Care Measure Workgroup (Emily Transue, HCA)**

Emily Transue shared an update from this workgroup that QIC learned about in its June meeting that was convened by HCA as part of its efforts to build a Multi-Payer Primary Care payment model in the state. The table below summarizes the consensus-driven recommendations that this workgroup agreed upon advancing to the Performance Measures Coordinating Committee for consideration and acceptance.

### **Policy on Alliance Advisory Committee Work on Pricing Data**
